

Halal Compliance



More people are searching for halal alternatives to common cosmetics and personal-hygiene products as the Muslim population grows. Halal makeup is not new, nor is it a “trend”. It is becoming more of a popular demand. According to Pew Research Center, “Muslims comprise over 23 percent of the global population.”

The concept of halal cosmetics covers all aspects of production, not only focusing on sourcing of halal ingredients, but also on storage, packaging and logistics. Some high-end cosmetic companies have picked up on the demand of halal makeup and acquired halal certification.

There are a few leading certification agencies in the US, which are recognized domestically and abroad. They ensure that the prohibited ingredients and processes are not used during manufacturing. Samples are evaluated by an independent lab for traces of pork or pork by-products before certification is issued. The certification process can take months and comes with a high fee.

The majority of Kobo’s products are Halal Compliant since animal derivatives and intoxicating substances are not used as raw materials or auxiliaries. Halal Compliant statements are issued for those ingredients that comply upon request.



Ingredients derived from animals **CAN NOT** be used as raw materials and/ or processing aids in manufacturing

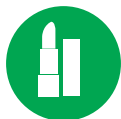

Manufacturing Procedure:

1. Combine all of Part 1 ingredients and prop mix at 80°C until homogeneous.
2. Pour into mold at @65°C.

3. Slowly add Part 1 and 2 to Part 3 until homogeneous.
4. Slowly add Part 4 to batch.
