## SECTION 3: HAZARD IDENTIFICATION

**Physical State and Appearance:** Solid (odorless, white powder)  
**Emergency Overview:** May cause respiratory tract, eye and skin irritation.  
**Routes of Entry:** Eye contact and Inhalation. Ingestion (not anticipated).
