Manufacturing Procedure

1. Pass the premixed Part 1 through pulverizer.
2. Add Part 2 and blend well. Do not overheat.
3. Add Part 3 and blend well at low speed.
4. Press at 1,000 psi.

This highlighting eye shadow's dual reflections of red and gold come from KTZ® Perpetual RedGold, which also gives sheen. Kobo's Silane-treated Sericite and Methicone-treated Mica give smooth application and transparency. Zinc Myristate is an excellent dry binder. SS4267 polymers contribute to long-lasting wear and prevent "creasing".
