## Description:

This long-wear eyeshadow provides a pop of color. It features Kobo's 11S Treatment which offers a creamy feel. The combination of BUP-11S2 and BTD-11S2 provides the lilac shade.

## Manufacturing Procedure:

1. Homogenize Part 1 until uniform.
2. Slowly add Part 2 to Part 1 under the homogenizer. Mix until homogeneous.
3. Combine Parts 1, 2 and 3 under the propeller mixer while heating to 85°C. Continue mixing until uniform.
4. Pour into air tight glass jars at 85°C.

## Notes:

After pouring let sample completely air cool to RT before putting cap on.
